

Area of Focus: Stroke**Learning Objectives:**

- Students will be able to identify the differences between a thrombotic stroke and an embolic stroke by their pathophysiology in their own words at the end of the lesson.
- Students will be able to recite the BEFAST symptoms (Balance Loss, Eyesight Changes, Face Drooping, Arm Weakness, Speech Difficulty, Time) in identifying an ischemic stroke at the end of the lesson.
- Students will practice three main nursing implications and interventions that are done in the hospital by the end of their clinical rotation.

- b. An ischemic stroke is when blood leaks around the brain tissue and a hemorrhagic stroke is when a clot is formed elsewhere in the body that breaks loose and travels to the brain.
- c. An ischemic stroke happens when a blood clot forms in an artery or is formed elsewhere in the body that breaks loose and travels to the brain, and a hemorrhagic stroke is a blood leak inside the brain or around the brain tissue.
- d. An ischemic stroke lasts only a couple of hours and a hemorrhagic stroke lasts forever.
