The concept is much narrower than other grand theories in which they give a broader range. Three key points that describe a middle-range theory consist of a description of a particular phenomenon, its explanation of the relationship between phenomena, or even predicts the effects of one phenomenon or another. A middle-range theory falls between grand nursing models and concrete ideas in which they are more specific and have a limited number of concepts with a limited aspect of the real world. These middle-range theories relate to nursing practice in that they provide a basis for generating testable hypotheses for a particular nursing phenomenon and population as well. This makes middle-range theories much more applicable to practice situations. They are also used as frameworks for research studies.

This journal article talks about how middle-range theories hold value in helping to investigate nursing practices through the perspective of SDG, also known as Sustainable Development Goals, which are intended to promote an equitable, healthy, and safe world.
